
#### Analysis:

Graph 1: level of awareness of NEP-2020 among secondary school teachers.





**Graph2:**The significant difference between Male and Female secondary school teacher's awareness of NEP-2020





Graph3: the significant difference between government and private secondary school teacher's awareness of NEP-2020.




