The Spirit of man is of divine origin, for God has breathed of His own spirit into him. It is an unfathomable secret ---- a command of a God, of knowledge of which only a little has been communicated to man and he alone has given the capacity to use names for things and so has been given the knowledge which even the angels do not possess. Among men those who are granted wisdom are indeed granted great good.

The conscious self is of three degrees. In the first degree it is the impulsive self (mind) which man shares with animals; in the second degree it is conscientious or morally conscious self (intellectual-mind), struggling between good and evil and repenting for the evil done; in the third degree it is the self perfectly in tune with the divine will, the self in peace (spiritual-self).

The Main Concepts:
